

# Peer Worker Apprenticeship: Provider Networking Directory



## Guidance Notes

This Directory supports the ambition for peer supporters to work alongside providers, promoting the fundamental principles of working from a lived experience perspective. This directory aims to ensure the apprenticeship actively involves those with understanding of lived experience and the peer worker role in all aspects of the apprenticeship delivery, including assessment and training opportunities.

### What is the Peer Worker Provider Directory?

This directory is a list of providers both large and small, who have expressed an interest in working collaboratively to support the implementation of the Peer Worker Apprenticeship. For the successful implementation of the apprenticeship, it is vital that large training providers can design the delivery and learning materials to ensure peer/lived experience voices are at the heart of the apprenticeship delivery.

All those in this directory have consented to their contact details to be included so that they can start conversations and explore partnership delivery arrangements / subcontracting to achieve the ambition of the peer worker apprenticeship.

### What do we mean when we say large and small providers?

When we talk about large and small providers in the context of the peer worker apprenticeship, we mean:

- **Small Provider** - A small provider who currently provides excellent peer support training, but who isn't on the Register of Apprenticeship Training Providers (RoATP) so is unable to deliver apprenticeship training directly themselves.
- **Large Provider** - A training provider who is already on RoATP and is able to deliver apprenticeship training themselves, but who needs the industry expertise of smaller peer support organisations to design and deliver the specialist training within the apprenticeship.

### Why has the directory been developed?

It was recognised during employer conversations that the technical apprenticeship delivery expertise sits with large training providers, this is because they are registered to deliver apprenticeship training on the Governments [Register of Apprenticeship Training providers \(RoATP\)](#), to apply to this register they have had to meet high quality standards and are inspected by Ofsted and ESFA. Small providers who currently provide excellent peer support training currently aren't on the governments RoATP and most have no history of delivering apprenticeship education.

Therefore, this directory was developed to support both large training providers and small providers to make connections and develop co-produced models for the delivery of the peer worker apprenticeship. This will ensure that the apprenticeship is representative of the peer worker role.

Employers are working towards procuring training providers for the apprenticeship in Spring 2022, therefore it is important that large and small providers use this directory as a supportive tool to start conversations with each other about delivery models in preparation for procurement in Spring 2022.

### **How should I use this directory?**

The aim of this directory is to support innovation and should be used as an enabling tool to support large and small providers networking and conversations. Therefore, there is no set criteria about how you should use the directory, this is to be determined by how you wish to engage with the apprenticeship and the needs of your business. For example, you may wish to contact a handful of providers to have initial informal conversations about what you can both offer each other in terms of expertise, this may then formalise into a contractual arrangement, for example:

- Offer trainers experienced in peer support to provide training on the apprenticeship
- Support the co-production of the curriculum of the main provider
- Provide expert guidance and consultancy about delivery models

### **How will the directory be managed?**

The National HEE Talent for Care Apprenticeship Team will regularly review and update the directory. It will be available online at [HASO](#) to ensure accessibility and version control.
