APPRENTICESHIP OVERVIEW

Podiatrists are registered healthcare professionals specialising in the lower limb (feet, ankles, legs). They help people of all ages deal with a range of mobility issues, relieve pain and treat infections.

Podiatrists work with other healthcare professionals such as physiotherapists, dietitians, GPs and nurses and in a range of settings from hospitals and community clinics to the homes of patients.

ENTRY **REQUIREMENTS AND** QUALIFICATIONS

Entry requirements

The employer, in partnership with the university, will determine the selection criteria for apprentices. Typically they will require 3 A levels, a BTEC National Extended Diploma or equivalent access qualification.

Apprentices without level 2 English and maths will need to achieve this level prior to completing the end-point assessment.

Apprentices will be required to complete a Health and Care Professions Council (HCPC) approved BSc (Honours) or (where the apprentice already holds a level 6 honours degree) a pre-registration MSc in Podiatry



Qualifications

All apprentices must also pass the apprenticeship end-point assessment.

REGULATOR AND PROFESSIONAL BODIES


Podiatry is a profession regulated by the Health and Care Professions Council (HCPC). The HCPC sets out the standards of proficiency which every Podiatrist must meet in order to become registered.

Once registered, Podiatrists must continue to meet the standards of proficiency that are relevant to their scope of practice - the areas of their profession in which they have the knowledge and skills to practise safely and effectively.

Podiatrists may become a member of a professional body like <u>The British Chiropody and</u> Podiatry Association (BCHA), The Institute of <u>Chiropodists and Podiatrists (IOCP), The College</u> of Podiatry (COP) and The Alliance of Private Sector Practitioners (APSP).



On successful completion of an approved programme, apprentices are eligible to apply to the HCPC for registration as a Podiatrist, which is a requirement to practice under the protected title of Podiatrist.



Training Provider

All providers who want to deliver apprenticeship training must be on the Apprenticeship Provider and Assessment Register (APAR). Employers must choose a provider from the Register.

Providers must meet a clear set of criteria in order to be included on the Register. These include financial health, capacity/capability and quality criteria. If a provider does not meet these criteria they will not be included on the Register.

End point assessment

As part of their apprenticeship, apprentices will have to complete end point assessment.


The end-point assessment organisation will assess the apprentice in line with Podiatrist (Degree) End-point Assessment Plan. This ensures that all apprentices are assessed holistically to a consistent standard at the end of their apprenticeship.

Organisations offering end-point assessment will need to be registered on the Apprenticeship Provider and Assessment Register (APAR). As a degree apprenticeship, the end-point assessment for Podiatrist apprentices is integrated into the degree. This means that the end-point assessment organisation will be the university.


APPLYING AND PROGRESSION ROUTES


Candidates interested in applying for the Podiatrist (Degree) apprenticeship should visit <u>NHS Jobs</u>, <u>Find an Apprenticeship website</u> and the <u>Find apprenticeship training for your</u> <u>apprentice</u> website. It may also be worth contacting training providers directly to make enquiries about the apprenticeships they offer.

Podiatrist apprentices will be over 18 and may earn more than the minimum apprenticeship wage. Pay is determined locally so whilst it may be higher, it cannot be lower than this amount. O Click here for more information on apprentice pay.

Once qualified Podiatrists in the NHS will typically earn between £24k - £30k. With experience and further training, Podiatrists can choose to specialise in sports injuries, diabetic footcare or work with children. Many will choose to work in the private sector, either for high street stores or as independent practitioners running their own business.

Podiatrists can move into teaching or management where they would be responsible for a team and manage budgets. There is also opportunity to train as a podiatric surgeon.
